NASH FM 93.7'S "WIN FALLFEST TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **NASH FM 93.7's "Win Fallfest Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. **Contest Period.** The Contest entry period will begin at **10:00am ET on Monday, September 2, 2024** and will **run** through **11:59pm ET on Sunday, September 8, 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is one way to enter.

Facebook: Entrants must:

- (a) Visit the Station's Facebook page at <u>www.facebook.com/nashfm937</u> during the Contest Period;
- (b) Comment on the "Win Fallfest Tickets" Contest post;
- (b) Tag another user's account; and
- (c) Include in the comment: #contest.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the

Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

- 4. **Winner Selection.** On or about 11:00am EST on Monday, September 9, 2024, Station will select THREE (3) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. - 7. Entry Conditions and Release.
